

All entries received must be received on April 16, 2024. Draws for in-person attendees will take place on April 16 and online attendee draw will take place on April 17, 2024.

No purchase of any kind is necessary to enter or win. Void where prohibited by law. Entry into this Draw Contest constitutes your acceptance of these official rules and regulations.

WHO MAY ENTER

To be eligible for this Draw, an individual must:

- be a legal resident of Ontario, Canada; and
- be 18 years or older at time of entry; and
- be a current member, and;
- not be employed by Kindred Credit Union, its affiliates, or subsidiaries. Immediate respective family members of Kindred employees, and anyone with whom such employees are domiciled, are also not eligible.

DRAW CONTEST PERIOD

The Draw Contest period begins Tuesday April 16, 2024 at 6:30 p.m. and closes at 8:00 p.m. EST on the same day.

HOW TO ENTER:

In-person attendees will receive a *Kindred Credit Union Draw ballot* at the registration table. Deposit the completed ballot in the ballot box located at Knox Presbyterian Church, 50 Erb St. W, Waterloo, Ontario on Tuesday, April 16, 2024 between 6:30 p.m. and 8:00 p.m. EST. Online attendees to the 60th Annual General Meeting will be automatically entered into the draw.

Maximum one entry per member meeting the Draw Contest eligibility requirements.

All entries become the property of Kindred Credit Union and will not be returned. We respect your privacy and will not sell or trade your information to any outside parties. The personal information provided in the Draw Contest will only be used to administer the Contest, or by providing your email address, you consent to Kindred Credit Union using your personal information from time to time, for marketing purposes, such as providing you information about our products, services, and/or community activities that may be of interest to you or the third party for whom you are acting. These emails will provide you with an option to change your consent at any time. You can also change your consent by calling or visiting your local branch.

All entrants must meet the eligibility requirements set forth in these rules in order to qualify for the prize. By entering, entrants agree to be bound by the contest rules and the decisions of the judges, which are final, and consent to the use of their name, address and/or photograph, without compensation, in any future publicity carried out by Kindred Credit Union in connection with this contest and/or in connection with any other advertising carried out by Kindred Credit Union.

PRIZE

There will be five (5) prizes in total awarded as follows:

- Two (2) 'Second Prizes' of a Kindred 60th Anniversary gift pack, valued at approximately \$50 each. One (1) 'Second Prize' will be awarded to an in-person attendee and one (1) 'Second Prize' will be awarded to an online attendee.
- Two (2) 'First Prizes' of a \$500, 12-month term, Kindred Credit Union GIC at the posted rate at time of acceptance. Rates are subject to change at any time, without notice. One (1) 'First Prize' prize will be awarded to an in-person attendee and one (1) 'First Prize' will be awarded to an online attendee.
- One (1) 'Grand Prize' of a Kindred 60th Anniversary quilt awarded to an in-person attendee only.

The prizes must be accepted as awarded. No substitution of prizes is permitted except by Kindred Credit Union, in their sole discretion. Kindred Credit Union reserves the right to substitute any prize with a prize of equal value for any reason whatsoever. The prize is not redeemable for cash or credit, in whole or in part. WINNER SELECTION

There will be three (3) separate winners selected by a random drawing at Knox Presbyterian Church, 50 Erb St. W, Waterloo, Ontario at **approximately 8:20 p.m. on Tuesday, April 16, 2024**; one (1) 'Second Prize', one (1) 'First Prize' and one (1) Grand Prize' from among all eligible entries received by in-person ballot during the contest period.

There will be two (2) separate winners selected in a random drawing in Kitchener, Ontario by the Contest Judges at Kindred Credit Union's Head Office at **approximately 11:00 a.m. on Wednesday, April 17, 2024**; one (1) 'Second Prize', one (1) 'First Prize' from among all eligible online attendees.

The actual odds of winning will depend upon the actual number of entries received during the contest period.

In-person attendee winners will be notified at the Annual General Meeting, during the meeting hour(s) and online attendee winners will be notified by email and/or by telephone. Decisions of judges are final. No correspondence will be entered into except with the selected winner. In order to win the prize, the selected participant must meet the eligibility requirements as listed in "Who May Enter" and "How to Enter" above and have complied with all other official rules and must first:

- 1) Correctly answer a skill-testing question and;
- 2) Complete, sign and return an affidavit of eligibility and liability and publicity release (waiver), where permitted by law within fifteen (15) days of receipt of prize notification or prize will be forfeited and an alternate winner will be selected.
