Opened a new account recently or looking to switch to Kindred?

Use this checklist to make switching your pre-authorized payments to Kindred simple so your regular payments keep running smoothly and nothing gets missed during the move. Track payments to update, what information to share, and when each change is confirmed.

To set up pre-authorized payments, download Kindred’s Void Cheque form and send it to each of your depositors/billers.

If you do not currently have access to online banking or the app, you can download a blank [Direct Deposit / Pre-Authorized Payment Form](#).

TIP: Enroll in CRA direct deposit on online banking by navigating to Account Services in the left menu, then Set up CRA Direct Deposit. Personal members can receive the following CRA payments through direct deposit:

- ▶▶ Income tax refund;
- ▶▶ Canada Child Benefit;
- ▶▶ GST/HST credit;
- ▶▶ Canada Workers Benefit; and
- ▶▶ Related provincial and territorial payments.

With a personal account at Kindred, you can let ClickSWITCH take care of moving your direct deposits and pre-authorized payments from another financial institution.

TIP: ClickSWITCH works well for switching pre-authorized payments for most utilities. In other instances, it is quicker to work directly with the biller to switch banking details.

What you'll need to begin switching:

- ▶▶ Personal chequing account with Kindred;
- ▶▶ Online banking access with Kindred; and
- ▶▶ Your current pre-authorized payment and direct deposit information.
